Recreation & Master Plan Updates

Following a competitive bidding process the Township will retain the services of Spicer Group, Inc. to update the Land Use Master Plan and Recreation Master Plan for our community. In order to apply for many of the recreation grants offered by the State it is mandatory that these plans be in place and updated every five years. The process to update the two plans will be approximately 6 months and occur simultaneously. Public participation in the process will be requested via an online survey during the information gathering phase as well as one of the final phases of the process when the draft plan will be available at both the Township offices and public library for review. Information in regard to how to participate with the online survey will be provided on the Township's website as well as the Oscoda Press.

A Note From Your Treasurer

Pay your taxes by way of "auto deduct" at no charge. This will be a one-time payment deducted on the due date for each tax season. Go to our website to print a copy of authorization form or stop in the Treasurer's office for more details of this free payment option. Reminder: Winter Tax Bills are Due by February 15th. Wondering whether or not you paid your Summer taxes or just need to make sure you did? There is a place on your Winter tax bill that will tell you if you still have Summer taxes owing. Located on the top portion of your Winter tax bill, on the right, in the box titled "Payment Information" just below the mailing address there will be a message that reads "SUMMER TAXES OWING" if your summer taxes have not been paid. 
Aune Medical Center News

The Aune Medical Center is located on the Wurtsmith District (former WAFB) located on Skeel Ave. The facility is owned by Oscoda Township and provides medical services from the following tenants: Alcona Citizens for Health and Dental Center, Alpena Regional Rehabilitation, Alpena Urology, Oscoda Area Chiropractic Clinic, Turning Point Counseling and the Veterans Administration Community Outreach Clinic. New this summer the facility welcomed AuSable Valley Community Mental Health Authority as a new tenant and access to their offices can be made through the east entrance of the building. Construction has now begun in the northeast section of the Aune Medical Center to renovate approximately 7,200 square feet of vacant space for the Veterans Administration Community Outreach Clinic expansion project. The renovation is estimated to be complete in April of 2016 and will expand the current services offered to the Veterans in their existing location within the building. In addition to this renovation the entrance to the Alcona Dental Center will be improved with a new interior vestibule, replacement doors and a new window in the waiting room area. The majority of the construction renovations will not interfere with the daily operations of the Center...but like most construction projects noise may be a factor during certain phases of the project and we appreciate your patience and understanding as we move forward. Road Improvements

Interested in having your road improved? Based upon the Township Road Improvement Policy property owners can seek assistance from the Township and the Road Commission to share in the cost of a road improvement project. Specifically, if the Township Board approves a project a special assessment would normally be established for effected property owners. The cost of the project would then be allocated as follows: property owners 35%, Township 35% and Road Commission 30%. Water & Sewer

The 2014-2015 winter season provided extremely cold conditions driving frost levels to depths not seen in many years. This resulted in several frozen water services and frustrated property owners. In an effort to minimize confusion relating to property owner and Township responsibilities a Frozen Water Service Policy has now been adopted. Procedures identified in the policy are intended to maintain the Township's water distribution system, to prevent freeze ups and identify responsibility for thawing frozen main and services. Will It Flush? Although materials like facial tissues, dental floss, cotton swabs, feminine hygiene products, and kitty litter may flush down the toilet, they can cause clogged pipes for you and your neighbors. Items labeled as "flushable," such as baby wipes or personal care wipes, should not be flushed. These items can create a blockage in the line from your house to the sewer main, causing sewage to back up into your home. They will also clog sewer system pumps, causing backups that could affect an entire neighborhood. Please remember to only flush human waste and toilet paper. Snow Removal & Winter Preparedness

The Department of Public Works is requesting your assistance in keeping sidewalks and parking lots clear this winter. When plowing parking lots please do not leave snow in the sidewalk or do not place sandwich boards and other obstacles in sidewalk until snow has been cleared. As a reminder there is no parking in Township parking lots between the hours of 3 AM and 6 AM. Also, the Water Department would like to remind all homeowners, landlords and businesses to maintain a path to your water meter touch pad for monthly readings. If your meter pad becomes buried with snow or ice an estimated reading will be used for your bill. Remember to maintain your meters during the winter months to prevent freezing and breaking.
